- Any vendor who does not have a brick & mortor shop within the corporate limits
 of Big Stone Gap <u>MUST</u> purchase a Peddlers License in order to operate at any
 event, whether sponsored by the Town or a local business/organization.
 The fee for the Peddlers License for all peddlers, vendors, and mobile food units is
 \$30. Solicitors <u>only</u> must pay an additional one time non-refundable background
- 2. ALL FOOD VENDORS will be <u>required</u> to complete the Meals Tax form and remit payment for said tax by the 20th of the month following the event.
 - a) A Town Representative will provide all food vendors with a copy of the Meals Tax Reporting form when they arrive.
 - **b)** For any event sponsored by a local business/organization the food vendor is still required to report and pay all Meals Taxes.
- 3. Additional vendor fees may charged by the event organizer for each event a vendor participates in.
