f. Projects Update

Mr. Lawson said that Councilwoman Bailey had fell at the doctor's office and suffered superficial damages.

Mr. Lawson said the Town of Big Stone Gap won the event of the year for the Blue Highway Festival at the International Bluegrass Music Association's award ceremony. Mr. Lawson said they took a group of town employees and Councilman Hughes to promote this year's festival. He said the Town would be in high gear next week to get everything ready for the Blue Highway Festival this year. Mr. Lawson said we are expecting a lot of special guests, including the Attorney General, to be here on October 12th at 3:30 pm to do a walking tour through Big Stone Gap and be back by 5:00 pm to greet people at Blue Highway. He will then be on stage to introduce the band and will have a press conference afterward. There will be other delegates coming but have not given a schedule, they will just be in attendance.

Mr. Lawson said we have Friends of the Festival dinner Tuesday October 10th at the John Fox Junior House from 7 pm - 9:30 pm with Carson Peters, Iron Mountain and Blue Highway performing. Mr. Lawson said the event is sponsored by the Ronald Blue Trust, who will also have delegates in attendance.

Mr. Lawson read a thank you card that was sent to Council for their donation of \$21,000 to the Union Primary School backpack program.

Mr. Lawson said the Office of Drinking congratulated the Water Treatment Department for getting the Virginia Department of Health 2023 Excellence in Waterworks Operations Silver Award.

Mr. Lawson said the basketball goals are up, got the last estimates for the coatings. He said the Town is going with Chris England's Xtreme Coatings.

Mr. Lawson said the Town had been pricing a Bobcat loader and a Case loader. He said the Bobcat loader came in \$18,000 cheaper than the Case loader, so the Town is going with Bobcat.

Mr. Lawson said that Boyd's construction started paving in the Town limits. He said they are on Italy bottom today, and have completed Big Stone Gap Heights, Dogwood Terrace, Azalea Lane, Moore Circle and Maxfield Road. 2nd Street Wyandotte to Shawnee around Municipal building was added to the schedule today.

Council Bloomer asked how many pickle ball courts there were to paint. Mr. Lawson said there were 5 pickleball and one basketball court. He said the Town was looking at cleaning out the alley at the Mooneyhan's and putting some there too.

He said all the concerts were great and that winning at the IBMA's is amazing. He said he is looking forward to the Blue Highway Festival next week and thanked everyone for everything.

Councilman Hughes congrats to Blue Highway and all the crews that work on that. He said he had heard really good things about the Carve-In and the State Cookoff Association event. He reminded everyone about the early voting in October, and Homecraft Days at Mountain Empire Community College on October 22nd - 23rd. Councilman Hughes said he would present the proclamation for Roy Cornelius Smith at the Pro Art Event on Sunday, October 8th. He thanked all the employees, fire department, police department and EMTs'.

Councilwoman Lyke said congratulations to the mayor, that he did a very good job at the State Cookoff Event. Also, congratulations on the Blue Highway Festival award and that she will be the only attendee at Virginia Municipal League Annual Conference October 7 - 10.

Mayor Johnson said we had great events with the bike race and the state cookoff. He said that they wanted to do another bike race by end of year because the scenery for the ride was great. He said all the events went smoothly and he was very impressed with the award he was presented with from the wood carvers at the Carve-In. Mayor Johnson thanked the town crews for their hard work on all the events and said that the music was great. He also said he had people come up to him to say we had it going on and that Delegate Terry Kilgore said this is the reason he loves coming to Big Stone Gap events to see things happening and he always has fun. Mayor Johnson said he was proud of the Town and now let's get ready for Blue Highway.
