AGENDA ITEM 5 - COMMENTS FROM CITIZENS

Larry Roberts, not a resident of Big Stone Gap, said he wanted to say thank you for the confidence and trust the Town had in him to head up the Blue Highway Festival. He said sadly he had decided to step aside but that he was raised in Wise County, he said this is home to him and he loves this place. He said one reason he took this on is because he loves bluegrass music, and this is where

bluegrass is from. He said that Ralph Stanley sang at his mom's graveside at Glencoe Cemetery and Big Stone Gap is special to him. Mr. Roberts said he wanted to give something back to where he was raised and where his heart was. He said that he and George Roat were friends, and they were together and said let's have a bluegrass festival and the town went on with that. He said we were talking about having the best bluegrass festival and in the first year we accomplished that with Blue Highway winning the IBMA Event of the Year. He said they sent out a questionnaire to people who had attended and the three reasons they loved the festival were: #1 the quality of the line up, #2 they were treated like family, and #3 accessibility. He said the festival was at a crossroads and he may have ruffled a few feathers with his enthusiasm and feels that others do not have that enthusiasm and that's why he feels he needs to step aside. He encouraged the Council members to review a text that was sent to Mr. Lawson and encouraged Mr. Lawson to share the text. He said it had been lots of fun and thanked Council for listening.

Roger Bays, Big Stone Gap, said he was here for support, and he knows how hard it is to start a festival. He said he was at a meeting trying to stir up tourism, and a lady there said any ideas that we can write on this chalk board, I said I would like to see a festival, and she said who said that, and that lady was Sharon Ewing. He said she and I got together along with my wife and Ron Short and started a committee to start Gathering in the Gap. He said that it was a fundraiser that raised over \$30,000 the three years he had it. He said we wanted it to grow and it's not an easy task and the festival leveled off, and along the way he resigned, because it was so much work. He said it was good thing to have something to draw tourism to Big Stone Gap, then then I hear the Blue Highway Festival is going to go its separate way, never got the promotion really needed to keep it growing. He said Blue Highway Festival has this momentum and is growing. He said two of his best friends have converted part of their homes to Air BNB's and that October is rented because of Blue Highway Festival. He said the festival is doing that for people, and he has no idea of the finances for this festival but is saddened that we are going to lose something that is growing.
