AGENDA ITEM 7 - TOWN ENGINEER'S REPORT

Mr. Lawson gave the Town Engineer's Report in the absence of Mr. Broskey. Mr. Lawson said on the System Wide Water Improvement Project Phase IA, 2A and 2B the Contractor was planning on starting back this week but due to the weather is waiting until next week. Mr. Lawson said on the System-Wide Water Improvement Project Phase III the paperwork had been signed and turned into the DEQ to work on the plans for this phase.

Mr. Lawson said we continue to work on the Big Cherry Outdoor Recreation Environmental Archaeological Study and are receiving quotes for that study.

Mr. Lawson said this was a resolution for Council to approve appropriating \$1,221,100 in ARC Funds for the Big Cherry Regional Recreation Enhanced Infrastructure Project.

Mr. Lawson said this was a resolution reappointing Freda Bishop to a four-year term on the Big Stone Gap Planning Commission to expire on October 31, 2028.

Mr. Lawson said this was a resolution reappointing Amy Hubbard to a four-year term on the Big Stone Gap Planning Commission to expire on September 30, 2028.

Mr. Lawson said this was a resolution reappointing Greg Kress to a four-year term on the Big Stone Gap Planning Commission to expire on July 31, 2028.

Mr. Lawson said this was a resolution reappointing Lorenzo Rodriguez to a four-year term on the Big Stone Gap Planning Commission to expire on July 31, 2028.

f. Projects Update

Mr. Lawson passed around a poster for the Skate Park and said that the American Ramp Company will be here on January 23, 2025 to look at the bike pump track site for the skate and bike park. He said the schedule for their visit would be as follows: 9 am – Design, 10 am – Visit the Site, 11 am – Lunch at Curklin's to meet with the family, 1 pm – Financials and remittance, 3 pm – Focus on Business, 4 pm – Focus on User, 5 pm - Dinner, 6 pm – Open Community Meeting.

Mr. Lawson said for website management Ked Meade and Amanda Hawkins had been talking with Ripl Creative for the town's websites bigstonegap.com, bigstonegap.org and Blue Highway Festival.

Mr. Lawson said the Town offices were closing at 12:00 pm tomorrow due to the weather forecast. He said the road crews would work the Prison Road and Azalea Lane first, Hospital second, then the main roads from town limits to town limits then the secondary streets.

Mr. Lawson said the Town does not clean sidewalks, that it is the businesses responsibility for the area in front of their business. He said with trash pickup that the garbage trucks can't always reach residences during bad weather so employees that are not scraping the roads are out in pickup trucks gathering trash.

Mr. Lawson said there would be changes within the Police Department due to the retirement of Chief Hamm.

Mr. Lawson said the date for Blue Highway Festival has been set and the official announcement will be after Monday.

Mr. Lawson said local businesses will be getting visits for past due accounts for Business Licenses, Water Bills, Meals Tax and other fees.

Councilman Gilley said the Planning Commission met Monday and the Tiny Houses Ordinance was completed and will be sent to Council for review.

He said it's wintertime and Legislative session will be soon; there are many folks without a home in Wise, Lee and Scott Counties and these Counties lack the resources to address the homeless population. He said everyone needs to contact the Legislation and the Commonwealth will have to tackle this problem eventually and provide these Counties with resources to help. He thanked all the employees for what they do for the Town.

Mayor Johnson said thanks to the Planning Commission for a doing a good job. He welcomed Adam Harris to the Planning Commission and said he was thankful to our employees and for everyone to stay safe and warm.
