k. Projects Update

Mr. Lawson said that Councilwoman Bailey is having complications from surgery and hopes she recovers quickly and to keep her in our prayers.

Mr. Lawson said for two months in a row Big Stone Gap has the Cover of the VRWA magazine.

Mr. Lawson distributed the reworked Tiny Homes Ordinance by the Planning Commission for Council to review and said that Charles Bledsoe has also received a copy for review. He said if Council had any questions to go ahead and ask Wendy Warden, she was in attendance. He said it is basically the same, that the Planning Commission took it into simpler form and followed what the State and County had done, so everyone will be on the same page for the Tiny Home Ordinance.

Mr. Lawson said the Blue Highway Festival committee was meeting weekly. He said we were contacting bands and sponsors and the week of February 3rd an official announcement will be made on the 2025 dates of the Festival.

Mr. Lawson said Skate Park meeting will be on January 23 from 9 am -7 pm. He said we need to get as many people involved and there as possible.

Mr. Lawson said Public Works were interviewing for two positions. He said they have two candidates they are making offers to.

Mr. Lawson said the Police Department made an offer to a certified officer who declined. He said there will be interviews for the DTF internal posting.

Mr. Lawson said weather is a battle and we are waiting for supplies and salt out of Ohio. He said there will be extremely low temperatures for the rest of the month.

Mr. Lawson said the LOVE sign at MECC has been delayed due to an ordering error in June and the metal had to be reordered.

Mr. Lawson said the Polar Plunge and the Chilly Chili Cookoff is February 1, 2025 with the Gap Partnership.
