## **AGENDA ITEM 5 – GAP PARTNERSHIP**

Elise Bloomer, President, Gap Partnership thanked Council for allowing her to come and speak. She said she is also the owner of 404 Café and Creamery in Big Stone Gap. She introduced Gretchen Cope who said she was the Treasurer of the Gap Partnership and Park Manager of the Southwest Virginia Museum. Ms. Bloomer said she came to ask Council to partner with the Gap Partnership for a permanent covered Farmer's Market. She said the vision is to create a covered open-air structure in Big Stone Gap that would act as a hub for local artisans and small businesses. She said

this would allow vendors to operate rain or shine and it would extend market dates. She said this space could be multi-use by all events held by the Town of Big Stone Gap. She said at this time they are requesting the Council's support to start the planning process, identifying a potential location, and researching funding sources. She passed out a picture to Council of what they were looking at doing for the project. Council had some questions and there was discussion on those questions.

Heather Moses, 418 East 5<sup>th</sup> Street South, came representing concerned citizens and brought a proposal for Council to consider, she handed out the proposal. She said this proposal is requesting a comprehensive study by the Weldon Cooper Center and Virginia Tech's Center for Economic and Community Engagement to assess the impact of Medicaid cuts in the Town of Big Stone Gap. ## c. Projects Update

Mr. Lawson said they received access to the Federal Building to take photos. He said we still need additional photos of the attic, crawl space and postal area to complete the application and meet the May 6<sup>th</sup> submission deadline.

Mr. Lawson said he had meetings with a podcaster from Heart of Appalachia Tourism Authority that was sent to Big Stone Gap for our outdoor recreation activities including the Greenbelt, Powell River Trail, Big Cherry and the AMLER grant. He said they would get back with us in May and would go live with the podcast. He said he would keep Council informed because several will need to be involved. He said the state parks was one of the sponsors and this was a regional plan put together to get tourists to stay longer than a weekend.

Mr. Lawson said Blue Highway dates have been finalized for October 8<sup>th</sup> through October 12<sup>th</sup>. He said all time slots have been contracted but there were still six contacts that need to be finalized. He said ticket pricing had been set, and marketing and advertising had been completed. He said he feels really good about this year's show. He hopes to announce everything by April 21<sup>st</sup> but no later than May 1<sup>st</sup>.

Mr. Lawson said the Easter egg hunt is this weekend and is always a big event.

Mr. Lawson said the Town was cleaning up the concrete where the Post Office is relocating and that was part of the agreement and that they plan on being in that building by October 2025.

She said she volunteers with a lot of different organizations and would like to see the proposal Heather brought on the agenda.

Councilman Hughes said it was good to be with all the people at MEOC at the Pinwheel Ceremony. He thanked the visitors for coming and bringing their presentations. He said he shares in the concern right now with the changes in government and the effect it will have on rural America and Southwest Virginia, and it will eventually affect us on the local level. He thanked all the police, fire and rescue and all the town employees.

Councilman Gilley said thanks to all employees, and he hopes Gary is ok.

Councilman Bloomer said he was sorry he missed the Pinwheel Ceremony, and he apologized. He said he; Elise and Amanda attended the Gala and had fun. He said the Minnick School wants to have a grand opening and ribbon cutting the 1<sup>st</sup> or 2<sup>nd</sup> of May and he will let everyone know when they decide. He asked what the update was on the skate park, Mr. Lawson said they would have the next graph for us by the of end of this week. Councilman Bloomer also asked about the splash pad, Mr. Lawson said it would be ready by the 2<sup>nd</sup> week of May.

Vice-Mayor Bailey thanked everyone for coming and the presentation for the Farmer's Market and Heather for bringing the Resolution. She thanked the police fire and all our town employees.
