1. Projects Update

Mr. Lawson gave the following updates:

- The Architectural Review Board ordinance needs to coincide with the Town Charter and State Law and also to give property owners a 30 days' notice to provide their input and concerns. Council and Town Attorney Bledsoe will need to review and recommend changes to give feedback to the Planning Commission.
- The Yard Sale Policy did not work before years ago and it will not work now but it can be policed better regarding the signs. Town staff would not be available to keep up with the things mentioned in the Policy, it will need to be revised.
- GSA compliance document has been signed and returned. Applause to Matthew Bright and Ked Meade and anyone else who worked on the document. The resolution will be sent after tonight's meeting, and the Town will know soon if we have control of the Federal Building.
- May 24th Kid's Fishing Day and Gathering in the Gap. Stocking of trout will be next Thursday, invited everyone to participate in the stocking of the trout. Big Cherry will be closed to the public after the stocking until Saturday May 24th at 9AM.
- Artisan Well Hollow drainage issue with ditch that was blocked was found last Tuesday with the help of Lane Group. The drain was stopped up and Town crews will get new drainage tiles and clean the ditch.
- Adam Harris, Sandra Jones, LENOWISCO, DHCD and everyone involved in the Italy bottom project will have a kickoff meeting tomorrow in the Council chambers.
- Blue Highway Festival tickets went on sale midnight Monday May 12th. The victims of hurricane Helene that could not attend the 2024 Festival got replacement ticket to the 2025 Festival mailed to them.
- Ked Meade is working on submitting car charger grants that will include a 4-hour charger to be placed at the Municipal Building in one of the drive-thru bays. We have an opportunity to get a fast charger that requires 3 phase power. Councilman Bloomer mentioned at a previous meeting that this was the power is located in the 404 Café and Creamery parking lot. The installation for these fast chargers is \$20,000 25,000, a grant would be needed for this project.
- Skate Park meeting was today, and a total equipment groundbreaking will be happening in September 2025. The plans are finalized for the exact layout and location. The DCHD sign will be put up this month with the donors listed. This plant goes along with the VDOT grant

- for the sidewalk from the Museum to the Park. The linear feet has been changed to bypass the skate park since the previous grant was passed in 2017.
- The pool is beyond repair, and I am requesting that it be filled in and asphalted over. The Town of Pennington Gap has requested to purchase the pool pumps, and I suggest that we give them the equipment since they have the only working pool in the area. Council agreed.

Acting Committee Chair Hughes said the Public Utilities Committee met on May 13th to discuss the proposed utility rate increases for the FY 2025-26 budget and made the following recommendation.

The Public Utilities Committee unanimously recommends to Council an increase of 3% for in-town and out-of-town water and a sewer rate increase of \$1.00 to the over 1,000 gallons rate for in-town and out-of-town customers FY2025-26 budget to be included in the public hearing advertisement for Ordinance 14-2025.
