## AGENDA ITEM 5 – COMMENTS FROM CITIZENS

Joyce Palmer, President of the Lonesome Pine Heritage School, along with volunteers, came to ask for the plaques that were at the Armory to create a memory walk along the side of the Heritage Center. She said more people could see it at the School than at the hospital. She said she feel like she is in competition with Ballad and the Town to obtain the plaques. She said a letter was sent to Ballad to request the plaques. Stephen Lawson said Council does not usually talk during public comment, but he wanted to say Ballad was under contract to create a memorial park with purchase of the Armory and if not there then a memorial wall would be created near the library. He said Council would consider this as a third plan for plaques.

Adam Harris – 413 E River Street – came to Council asking for more parking at Italy Bottom Park. He said he would like to see angled parking with striping and handicap spaces. He said the removal of two trees there would make more spaces available.

James Terrell – 476 Ridge Place – came to address Council of the lack of enforcement of the removal of inoperable vehicles. He said it has been thirteen months since the Ordinance passed and has only seen two cars moved. He said when he looks out his window he sees multiple cars that are inoperable with weeds and overgrowth. He said either Wise County or someone on Council is not enforcing the Ordinance and needs to follow up and take action on this.

## f. Projects Update

Mr. Lawson gave the following updates:

- Small Business Association asked Council for \$5,000 still waiting to hear on what the money would be spent on.
- Special Use Permit August 6th spoke with Stephen Murray and told him to submit a formal letter outlining the intended process.
- Planning Commission had asked about parking at Italy Bottom Park, and to also address the public comment by Adam Harris, the current housing development plan for Italy Bottom includes that the Green Belt tie-in will be where the ask is for parking. As plans go forward we will look at changes that can be made to accommodate more parking.
- Planning Commission ask for parallel parking being reinstated on the northside of East 5<sup>th</sup> Street to the corporate limits there has been no contact with VDOT or anyone professional, but going out and looking would not recommend that the request be approved.
- Council comment at corner by Food City onto Shawnee has not talked to property owner but there is a power pole there that could be an issue. Again, VDOT has not been contacted.
- Council request for tree trimming has been taken care of by Town crews in that alley.
- LED lighting at Bullitt Park went well with some concern about a glare light along the track and lighting behind the visitor bleachers, all this has been taken care of.
- There are some ruts and places where the asphalt needs to be repaired, and we are looking to concrete the area rather than fix asphalt at Bullitt Park.
- Councilwoman Bailey asked if requests were still being taken for paving and Mr. Lawson replied yes, Bailey said there was a large pothole on West 1<sup>st</sup> Street that needs repair along with West 3<sup>rd</sup> Street. Councilwoman Lyke said Azalea Lane not paved in several years.
