Mr. Lawson gave the following updates:

- The Italy Bottom Rehab project started today with Adam Harris being named Chair and Sandra Jones Vice-Chair. We are getting a list of contractors together and the rehab specialist will go to each home that was selected and confirm the list is correct in determining on what needs to be completed.
- The Pump Track is ahead of schedule, if the weather holds it will be completed before Christmas. We will do the Grand Opening in the spring. We do have money for the Grand Opening Ceremony but would like to ask local people and businesses to donate bikes, skateboards, etc. to do a drawing to give them to kids. There will be signs that helmets are required and to use the skate park at your own risk.
- The Campground Ordinance was not put to a vote at this meeting because it needs more work to the wording, and due to Councilman Hughes and Mayor Johnson's comments from the Workshop Meeting, and other concerns.
- Black Horse Cycles ribbon cutting is Friday, November 21, 2025 at 12:00PM.
- Council was asked to check their emails regarding some information that had been sent on employees.
- Aldi Grocery is offering a Thanksgiving Dinner for \$40 that will serve 10 people. The Town will purchase 40 meals, 20 for Thanksgiving and 20 for Christmas. Recipients must be able to cook the meal. The Town received names from different Organizations and local Citizens of families or individuals that would need a meal in each section of Town. The Police Department will deliver the food boxes in the Bear Car.
