Projects Update

Mr. Lawson gave the following updates:

- Sidewalk – commend Pat McKinney and Jon Broskey's work on this project. This project started in 2018 and now that the skate park is completed this would give us an ending route. VDOT anticipates the project to be completed by June even with project being over budget.

Projects Update (Continued)

- Received calls about where doublewides are allowed vs. not. Modular homes are not a doublewide. VA DHCD has a plate that determines if it is a modular home or a doublewide, a paper explaining the description was handed out to Council.
- Tax reassessments are due every 5 years and is done by Wise County. The tax Rate for Big Stone Gap is only thing Council can change and must be done during the budget process.
- Isaiah 117 House sent a thank you for allowing them to come to Council and present their proposal. Meeting with Cindy Elkins with Ballard to discuss was cancelled and will be rescheduled. Councilman Bloomer asked if there was a backup plan if the property at the Hospital is declined for use, Mr. Lawson said the William's property on Orr Street would be the backup location. Councilman Bloomer suggested tearing down the Girl Scout Cabin near town hall, Mr. Lawson said there is a historical significance with that building and that other plans had been discussed for the use of it.
- Skate Park ARC grant will be finalized before adding to the project, any moneys left over will be used for landscaping the project. March 2026 a skate Park grant comes open in the amount of \$25,000 to be issued in June.
- Noah Mooneyhan lost a friend in an accident on I-81. He and a group of friends ask to help build a dirt bike trail back toward the pickleball courts and dedicate something in honor of his friend.
- Meeting with AMLER and Lenowisco is tomorrow to begin work on Big Cherry.
- Mural - Ked Meade has measured and took pictures of the side of the building in Miner's Park that Sara Botts owns for the RFP for the mural that Friends of Southwest Virginia has the money for will be going out by the end of the week.

AGENDA ITEM 9 - COMMITTEE REPORTS

Vice-Mayor Gilley said the Planning Commission is scheduling a special meeting on January 26th regarding the site plan review. He said after that meeting there may be more information for Council.

AGENDA ITEM 10 - COUNCIL COMMENTS AND DISCUSSION

Councilwoman Lyke knows how some feel about the 2nd amendment. She does think it would deter business from Big Stone Gap, and if it did deter business she would like to see studies on that. She said she has visited 43 out of the 50 states and never seen it deter tourism.

Councilman Hughes thanked James Porchie for coming to the meeting and the Public Safety Committee will have a meeting and find a solution for the problem on Aviation Road. He said he was excited to that the skate park was being so heavily used. He said he understand that some people are frustrated with the Resolution tonight, he said this Resolution is already in effect and does not see the need to revisit Resolutions that are in effect. He encouraged everyone to get their Flu shot because there is lots of sickness going around in the area. He thanked all the staff, Police, Fire and EMS.

Councilman Hollinger said he attended training last week and it a good training and he got to meet a lot of people from different areas. He asked Pat McKinney if it was his first time here, Pat McKinney answered yes, Councilman Hollinger congratulated him. He thanked Sandra Jones for coming to lead the invocation.

AGENDA ITEM 10 - COUNCIL COMMENTS AND DISCUSSION (Continued)

Councilman Harris welcomed Pat McKinney. He said he also went to Richmond for training, and it was great representing the Town of Big Stone Gap. He said it was a great networking opportunity and he learned a lot. He said like Councilman Hughes the Resolution is already in effect, and he is a gun owner, but he feels like there is no need to go back and keep doing Resolutions that are already done. He thanked James Porchie for coming and said Council would definitely look into his problem. He thanked Pastor Jones for coming and leading Council in the invocation and all the guests in attendance. He thanked Ked Meade for all the Christmas activities.

Councilman Bloomer said he agrees with Councilman Hughes and Councilman Harris that Council voted on the Resolution once and it is already in effect. He said it is not Council's job to determine what is constitutional, that it up to the courts, Council does not get paid for that. He said the lights and the controller on the pedestrian bridge were stolen, he asked Council if anyone sees them to let him know. He asked about the sidewalk at Winky Whitt's property, are we waiting on weather. Mr. Lawson said yes we are waiting on the weather, but it is still in the plans.

Vice-Mayor Gilley said he respects everyone's view on the 2nd Amendment to everyone, but many people have asked him about it, he set a motion to put the 2nd amendment back on the agenda, Lyke seconded. Ms. Hawkins said since the item was already removed from the agenda it will have to be put on February's agenda to be voted on. Lyke asked for it to be put back on the Agenda for February. Councilman Harris asked that if this is already a Resolution, did it change, or are we just revisiting it due to the change in Government. He said the Resolution is already in effect for the Town of Big Stone Gap, so he thinks Council does not need a Resolution that is already in effect. Councilman Bloomer said a Resolution like this opens the Town up to liability and asked if the Town decided not to enforce or to enforce the law would our insurance cover it. Vice-Mayor Gilley said it is showing support. Councilman Hughes said it seems to be political and was adopted previously. Councilman Harris said if citizens have any questions regarding the 2nd Amendment to refer them to the Resolution that was adopted in 2019. Councilman Bloomer said that Council took an oath to uphold the Constitution which means Council must obey all laws passed by Government. Mayor Johnson said if it was already adopted why do it again. Councilman Bloomer asked is there a reason to redo the Resolution. Attorney Bledsoe said there is no expiration date on a Resolution and once in effect, it is always in effect, unless overturned. Vice-Mayor Gilley said he is doing what citizens have asked for. Ms. Hawkins said again citizens need to refer to the 2019 adoption, and they can request a copy. Mayor Johnson asked could Council print something about the Resolution in the Post. Ms. Hawkins said if Council wants the Resolution published in the Post she can have it in next week's edition.
